REGISTRATION AND ADMISSION:

I. REGISTRATIONANDADMISSION:

- 1) Applicants must meet Eligibility Criteria for the Course applied for.
- 2) Eligible applicants must submit Application Form along with requisite fee and all supporting documents
- 3) Admission shall be confirmed subject to submission of all the required documents and payment of Registration fees
- 4) In the event of any information or document submitted by the Applicant being found to be incorrect or misleading, MODERN TECHNICAL EDUCATION SOCIETY, reserves the right to cancel Admission of the candidate without any fee refund.
- 5) In case the student wishes to pursue a Course other than the one for which Admission was taken, he/she can do so by giving a written request to the Management. However, this option is available only within 15 days from the date of Commencement for Course initially applied for.
- 6) MTES reserves the right to reject any application without giving any reason.
- 7) This certificate is applicable only for employment in the private sector. It is not valid for government job applications."
- 8) It is mandatory for the certificate holder to establish and maintain a Primary Health Care Centre (PHC) in a designated rural area, in accordance with the applicable rules and guidelines.

VIII. PROHIBITED ITEMS:

IX. ATTENDANCE

- 1) Minimum 70% attendance in classes is compulsory to become eligible to appear for Examinations.
- 2) Minimum 85% attendance during Clinical Internship is compulsory.

X. EXAMINATIONS AND CERTIFICATIONS

Module Based Assessments, Final Foundation Exam and Pre-Internship Exam.

- 2)TheCourseCompletion CertificateMTESshallbeawardedonly afterpayment offullCourse fee, passing the PreInternship Examination and Clinical Internship.
- 3) If the student fails to achieve the minimum qualifying marks, they shall be provided with an opportunity to appear for a Remediation Exam. However, acost of as per Exam Remediation Exam would be charged for each such further exam.

XL CLINICAL INTERNSHIP

- 1) Inordertoqualify for Clinical Internship, the student must secure at least 70% marks in Pre-internship Exam.
- The Management will always endeavor to refer students for Clinical Internship in organizations based in near by areas. However, specific requests from students for location preferences shall not be entertained by the Management.
- During the Clinical Internship, the student shall be subject to the Rules and Regulations as are applicable to the organization where they are undergoing their Clinical Internship.

XII". PLACEMENT

I) MTES provides placement support to students who successfully complete the Course and does not guarantee placement to any student.

- 2) Only students who have completed Clinical Internship and Examination shall be eligible for placement support.
- 3) Placement support will be available for a period of 3 months from the end of Clinical internship
- 4) Ultimate placement of the student depends on their performance in the course, interview and other factors. The decision to join any organization rests with the student and MTES is not responsible for their finalization of salary, location or other employment terms.

XIII. DRESS CODE POLICY:
